Northwest Voyageurs Boat Rental Options

 **Whitewater Kayaks** - The usage of the agreed NWV equipment is for a single or multiple trips and possession of the said equipment. The fees associated with rental are \$100 per year.

 **Touring Kayaks** - The usage of the agreed NWV equipment is for a single or multiple trips and possession of the said equipment. The fees associated with rental are \$100 per year.

 **Canoes** - The usage of the agreed NWV equipment is for a single or multiple trips and possession of the said equipment. The fees associated with rental are \$100 per year.

READ BEFORE SIGNING:

Waiver and Release of Liability: This Waiver and Release of Liability covers all activities directly or indirectly associated with the use of Northwest Voyageurs Canoe & Kayak Club's rented equipment. The undersigned expressly assumes all liability that may arise from the inherent risks associated with the use of the rented Northwest Voyageurs Canoe & Kayak Club's equipment and accepts that canoeing and or kayaking may involve the unavailability of emergency care and any unforeseen circumstances which may entail unavoidable risks of personal injury, illness from infectious disease, loss of or damage to personal property and or even death. I voluntarily choose to participate in the use of this equipment in spite of these risks and hereby assume all risk of injury, disability, death and loss of or damage to one's own or borrowed property. I fully understand that I will be canoeing and or kayaking at my own risk. I agree to abide by the rules, regulations and or safety warnings of the Northwest Voyageurs Canoe & Kayak Club and or its agents as well as any other governing rules and regulations that exist at time of acquisition, delivery, transport or use of said club equipment at any and all trips whether club sanctioned or non-club sanctioned trips.

Terms and Conditions of the NWV Rental Agreement

- Equipment outlined within the contract may be used for NWV club trips only without purchasing additional insurance. For non-club trips, the undersigned member agrees to provide insurance specifically to cover loss or damage to the rented equipment
- While using club equipment all parties agree to wear a PFD or life jacket and use all safety equipment at all times when upon the water
- All NWV club boats come with all government required safety gear as outlined in the following table
